SUMMARY OF CHANGES

CHAPTER 5

1. Section 1. This change allows the addition of zip codes enclosed entirely within a Prime Service Area's (PPAs) boundary to be included in the PSA. EFFECTIVE DATE: September 15, 2016.

CHAPTER 6

2. Section 1. This change updates DEERS when Prime enrollment fees are refunded and/or forfeited. EFFECTIVE DATE: September 30, 2016.

CHAPTER 8

3. Section 1. This change clarifies effective date of enrollment for newborns or adoptees deemed to be enrolled in Prime and deletes obsolete language. EFFECTIVE DATE: September 15, 2016.

CHAPTER 16

4. Section 1. This change adds a cross reference and revises language on enrollment fees reporting in Defense Enrollment Eligibility Reporting System (DEERS). EFFECTIVE DATE: September 15, 2016.

CHAPTER 24

5. Section 30. This change corrects a misspelling of the word TRICARE. EFFECTIVE DATE: September 15, 2016.

CHAPTER 25

6. Section 1. This change adds language as to when TRICARE Young Adult (TYA) enrollment applications from the Beneficiary Web Enrollment (BWE) for the TRICARE Overseas Program (TOP) Contractor are effective. EFFECTIVE DATE: September 15, 2016.
