SUMMARY OF CHANGES

CHAPTER 4

1. Section 4. This change reverses some of the reimbursement procedures incorporated in Change 70 (dated July 27, 2012) to the TRM, Chapter 4, Section 4. Specifically, it reverses the language currently in TRM, Chapter 4, Section 4, paragraph 1.3.1.2 stating that TRICARE will not consider coverage when Medicare makes no payment on the claim, requiring the provider/beneficiary to file an appeal with Medicare.
