SUMMARY OF CHANGES

CHAPTER 3

1. Section 1.3. Added new paragraph 6.1.2.10. Paragraph includes Health Care Plan: TRICARE Reserve Select Program and description.
2. Section 1.5.
 - a. Added new paragraph 1.2.8.4, "Premium Payments". Paragraph adds requirement for contractors to handle premium payments received for the TRICARE Reserve Select Program and apply an appropriate "paid through" date on DEERS.
 - b. Paragraph 1.4.2, revised to indicate that unsolicited notifications may be received by contractors on behalf of the TRICARE Reserve Select program.
 - c. Paragraph 1.5., revised to indicate that enrollment cards will be produced for the TRICARE Reserve Select Program. And added clarifying language to indicate PCM selection letters will be issued for TRICARE Prime and TRICARE Prime Remote enrollment.

 - h. Business Rule J: Added process for Online Enrollment Fee Payment for TRICARE Reserve Select.
